Price Structure	The Starion EcoGreen Secure plan includes a <b>fixed</b> rate per kilowatt hour(kWh). Your fixed rate will remain the same for each billing cycle during the Initial Term. Starion will calculate your supply charges each billing cycle by multiplying your fixed rate by the amount of electricity used.
Generation Supply Price	Your fixed rate will be <b>\$0.0689</b> per kWh for each billing cycle during the Initial Term. Thereafter, your fixed rate will be determined by Starion and you will be notified of such rate at least 30 days in advance, unless you select a different option. See 'Renewal Terms' below for more information.
Statement Regarding Savings	Starion does not guarantee savings.
Deposit Requirements	None.
Contract Start Date	Starion will begin to provide your electric generation supply within 1-2 billing cycles from enrollment, based on your next available EDC meter read date.
Contract Term/Length	Your <b>Initial Term</b> will be <b>9</b> billing cycles. Thereafter, your term will be determined by Starion and you will be notified of such term length at least 30 days in advance, unless you select another product. See 'Renewal Terms' below for more information.
Cancellation/Early Termination Fees	None.
Renewal Terms	You will receive two (2) notices, approximately 60 and 30 days before the expiration of your Initial Term, which will explain your options going forward.
